## 1. Purpose of policy and guiding principles

- 1.1. The purpose of this policy is to define The Xavier Catholic Education Trust's commitment to equality ineverything that we do.
- 1.2. Xavier Trust is committed to equality in both employment and education provision. We recognise the diverse nature of our locations and services and aim to ensure that students, parents, governors, employees, contractors, partners, directors, clients and those who may potentially join the Xavier community, are treated fairly and with dignity and respect.
- 1.3. The Trust opposes all forms of discrimination and it is our policy and ethos to promote equality to all, irrespective of:
  - Age
  - Disability
  - Sexual orientation
  - Race (including nationality, ethnic or national origin)
  - Gender (including gender reassignment)
  - · Religion or belief
  - Pregnancy or maternity
  - Marital status (including civil partnerships)
  - Carer responsibilities
  - Domestic circumstances
  - Trade Union affiliation.
- 1.4. The Xavier Trust undertakes not to discriminate unlawfully, or treat people less favourably, on the grounds of any protected characteristics defined by the Equality Act 2010 (and any future amendments to the Act), or any other ground that cannot be justified.
- 1.5. The Xavier Trust recognises that it is also unlawful to discriminate by association or perception, e.g. treating a student unfairly based on the protected characteristics of their parents or other family members.
- 1.6. This policy recognises the four types of unlawful behaviour. **Appendix 1** provides these definitions.
- 1.7. Every possible step will be taken into account in the aim of ensuring individuals are treated fairly and decisions are based on objective criteria.
- 1.8. The Xavier Trust has a dedicated report form <a href="DIFT@Xaviercet.org.uk">DIFT@Xaviercet.org.uk</a> which is available to all members of staff, students and the community to report any incidents of discrimination using the DIFT Discrimination Incident Reporting Form and raise any queries in relation to equality, inclusion or diversity across the Trust.

## 2. Xavier Catholic Education Trust Mission Statement

Our mission is to provide an outstanding Catholic education for all the children in our schools and exceptional training for teachers at all stages of their career.

We will follow the example and teachings of Christ and everything we do will be inspired by gospel values. We will strive for excellence in all areas of our work and cherish every child and member of staff in our care.

#### 3. Consultation

- 3.1 Directors and Senior Leaders have been consulted on this policy and its ethos and aims have their fullcommitment.
- 3.2 Further information on consultation and engagement is outlined in **Appendix 2**.

## 4. Links with other policies or legislation

- 4.1 This policy and its ethos apply to every policy, procedure and guidance document that is produced inrelation to students, staff, parents and governance.
- 4.2 The following policies are particularly relevant to achieving the objectives of this policy:

  - Admissions policy (school-based policy).
  - Anti-bullying policy (school-based policy).
  - Behaviour for Learning policy (school-based policy).
  - Xavier Supporting Children with Medical Conditions Policy.

  - All other Xavier employment policies.
- 4.3 This policy is underpinned by the Equalities Act 2010.

## 5. Public Sector Equality Duty (PSED)

- Under the Equality Act 2010 the Trust is required to meet the Public Sector Equality Duty (PSED). The Trust is required to have due regard to:
  - Eliminate discrimination, harassment, victimisation and other conduct that is prohibited by the Equality Act.
  - Advance equality of opportunity between people who share a protected characteristic and peoplewho do not share it.
  - Foster good relations across all protected characteristics between people who share a protectedcharacteristic and people who do not share it.
- 5.2 In relation to this our Equality Objectives are outlined in **Appendix 2**.

## 6. Equality Statement

There are some specific areas of the policy:

- 6.1 Xavier Trust will ensure that equal opportunities and the principles of fairness underpin all aspects of policy, procedure, education provision, consultation and decision making.
- 6.2 Xavier Trust is committed to equality in its delivery of education, whether or not the service is directlyprovided by us or contracted to a third-party provider. Senior leaders will monitor this education provision to ensure that students acquire the skills which enable them to be proactive in their behaviour and learning and to become responsible citizens.
- 6.3 We aim to provide high quality education services, making sure services are easily accessible. We will improve what we do by continuing to consult with staff, students, parents, governors, local communities and other partners about equality issues. We will promote our equal opportunities policyin our contact with parents, staff, governors and external organisations.

- 6.4 We will make every effort in creating equality of opportunity in order to ensure they are accessible and fair to everyone. Every person has the right to be treated fairly, regardless of any criteria as detailed on paragraph 1.3. Where necessary we will implement reasonable adjustments or additional support to ensure equality of access to an education and suitable learning and working environments.
- 6.5 Our staff and governors who plan, agree and deliver our education provision will recognise diversity and demonstrate a proactive approach in their day-to-day work. They will ensure that everyone is treated fairly, recognising special education or physical needs and understanding differences. Behaviour will reach our high standards of conduct (staff and students) and the learning environmentwe provide will be safe and accessible for those studying and working.
- The Xavier Trust will adhere to statutory legislation and give consideration to other relevant guidance, which aims to make sure that everyone is treated equitably. We will work with other people and organisations to encourage fair treatment of all. We will collect information, which will help us plan and develop services to meet the special needs of all members of the community.
- 6.7 The Xavier Trust will not tolerate any form of discriminatory behaviour against members of the Trustor local community.
- 6.8 Employment:
  - 6.8.1. The Xavier Trust is committed to ensuring that employees have equal access to recruitment andcareer opportunities, training, and professional development.
  - 6.8.2. The Xavier Trust recognises that the Act extends beyond the protected characteristics of an individual employee and has broader responsibilities to employees and situations that may be covered by the Act. For example, an employee with parental or caring responsibilities for a disabled dependent may have rights under the Act which the Trust, as their employer, would need to consider.
  - 6.8.3. All recruitment will be within the provisions of the Act and applications will be monitored to report on recruitment activity, in line with the Act.
  - 6.8.4. We will make every effort in creating equality of opportunity for employees, ensuring these are accessible and fair to all. Where necessary we will implement reasonable adjustments or additional support, to ensure equality of access to the working environment and opportunity to undertake the job role successfully.
  - 6.8.5. HR policies and procedures will be reviewed regularly to improve, adapt or amend current practices to promote equality of opportunities. All HR and employment policies will be applied consistently and fairly and refer to the provisions of the Equalities Act
  - 6.8.6. In addition, employees have access to a range of policies which aim to support and encourage flexibility and diversity in our workplaces.
  - 6.8.7. Employees who are in breach of this policy will be dealt with under the staff disciplinary policy.
- 6.9 Student provisions:

2010.

- 6.9.1 Xavier Trust and each school will ensure that students are provided with appropriate support to recognise their individual needs. This includes protection under the Act extending the reasonable adjustment duty to require schools to provide auxiliary aids and services to disabled students.
- 6.9.2 Protection under the Equality Act is extended to students who are pregnant, have recently given birth or are undergoing gender reassignment.

- 6.9.3 All policies relating to the provision of education, the curriculum, behaviour for learning, attendance, exclusion, medical treatment and Child Protection and safeguarding policies shouldconsider the provisions and duties of the Act. See Section 6.
- 6.10 Contractors and service providers:
  - 6.10.1 Across the Trust we will ensure that all service providers that are contracted to provide services to students, staff or visitors will comply with Equalities Legislation.
  - 6.10.2 Where services are deemed not to meet these standards, in relation to equal opportunities andfairness, contracts may be terminated.
  - 6.10.3 Provision will be made within Service Level Agreements between the Trust, or an individual academy and service providers or contractors, which will ensure that services are made available, with due regard for fairness and equality.

#### 7. Positive Action

7.1 Positive action provisions allow the Trust to target measures that are designed to alleviate disadvantages experienced by, or to meet the particular needs of, students with particular protectedcharacteristics. Such measures will need to be a proportionate way of achieving the relevant aim.

#### 8. Roles and responsibilities

- 8.1 The role of Directors and Local Governing Committees:
  - 8.1.1 Directors will approve this policy and are committed to ensuring that this policy is appliedconsistently and fairly.
  - 8.1.2 The Local Governing Committee will ensure that this policy is applied consistently and fairly in allaspects of school life.
  - 8.1.3 The Governing Body will monitor, evaluate and review policies in line with statutory and bestpractice guidelines.
  - 8.1.4 The Governing Body will nominate a SEN Governor with responsibility for monitoring the quality of the academy's SEN provision.
- 8.2 The role of academy and Trust leaders:
  - 8.2.1 The role of CEO is to ensure that this policy is applied fairly and consistently across the Trust.
  - 8.2.2 The role of a Headteacher is to ensure that this policy is applied fairly and consistently acrosseach school.
  - 8.2.3 School senior leaders will be responsible for ensuring that their school offers an inclusive curriculum, which promotes equal opportunity and good relations across all groups of students.
  - 8.2.4 School senior leaders will be responsible for ensuring that their school has in place a SEN policy, pastoral care policies and a Behaviour for Learning policy, all of which will promote equal opportunity and good relations across all groups of students.
  - 8.2.5 School Senior Leaders will be responsible for ensuring that their school develops teaching andlearning strategies and quality CPD that ensure all staff are able to deliver inclusive learning.
  - 8.2.6 The HR Director is responsible for all employment policies and ensuring the principles of thispolicy are reflected in all our employment practices. The HR Director will deal, in the first instance, with complaints raised under the grievance policy.

- 8.2.7 Finance Managers will monitor contractor and service provider compliance, and deal, in the firstinstance, with complaints.
- 8.2.8 Within each school the SENCo is responsible for the day-to-day management and coordination of education to students with special, or disability related needs.
- 8.3 The role of the employee/other staff:
  - 8.3.1 The role of all staff is to adhere to this policy, and the spirit of the law.
  - 8.3.2 Complaints from parents, students and the community will be dealt with in line with the academy's complaints procedure, and as such appropriate staff will deal with the relevant stage of the complaint.

## 9. Complaints

- 9.1 The Trust will treat seriously all complaints of unlawful (or potentially unlawful) discrimination.
- 9.2 Any complaints will be investigated in accordance with the grievance, dignity at work or complaintspolicy, whichever is appropriate.

### 10. Monitoring and Evaluation

- 10.1 Recruitment applications will be recorded and monitored to ensure compliance to the policy.
- 10.2 Requirements of contractors and other services managers will be monitored and documented throughservice level agreements.
- 10.3 Complaints will be monitored by the CEO's Administrator and the HR Director will monitor anygrievances bought in relation to this policy.
- 10.4 Any reviews to the policy will be consulted on and bought to a HR Directors' meeting.

## 12. Equality Impact Assessment

12.1 This policy sets out to ensure all stakeholders are treated equally and fairly during their relationshipwith the academy.

## Appendix 1

The Equalities Act 2010 defines four kinds of unlawful behaviour – direct discrimination, indirect discrimination, harassment and victimisation.

**Direct discrimination** occurs when one person treats another less favourably, because of a protected characteristic, than they treat – or would treat – other people. This describes the most clear-cut and obvious examples of discrimination – for example if a school were to refuse to let a student be a prefect because she is a lesbian, or an employee was refused a promotion because of their race.

**Indirect discrimination** occurs when a "provision, criterion or practice" is applied generally but has the effect of putting people with a particular characteristic at a disadvantage when compared to people without that characteristic. An example might be holding a parents' meeting on a Friday evening, which could make it difficult for observant Jewish parents to attend, or arranging the weekly CPD sessions for teachers on days when no part-time staff are available for work. It is a defence against a claim of indirect discrimination if it can be shown to be "a proportionate means of achieving a legitimate aim". This means both that the reason for the rule or practice is legitimate, and that it could not reasonably be achieved in a different way which did not discriminate.

**Harassment** has a specific legal definition in the Act - it is "unwanted conduct, related to a relevant protected characteristic, which has the purpose or effect of violating a person's dignity or creating an intimidating, hostile, degrading, humiliating or offensive environment for that person". This covers unpleasant and bullying behaviour, but potentially extends also to actions which, whether intentionally or unintentionally, cause offence to a person because of a protected characteristic.

Where schools are concerned, the offence of harassment as defined in this way in the Act applies only to harassment because of disability, race, sex or pregnancy and maternity, and not to religion or belief, sexual orientation or gender reassignment. It is very important to recognise that this does **not** mean that schools are free to bully or harass pupils on these other grounds - to do so would still be unlawful as well as unacceptable. Any case against the school would be on grounds of direct discrimination rather than harassment.

**Victimisation** occurs when a person is treated less favourably than they otherwise would have been because of something they have done ("a protected act") in connection with the Act. A protected act might involve, for example, making an allegation of discrimination or bringing a case under the Act, or supporting another person's complaint by giving evidence or information, but it includes anything that is done under or in connection with the Act. Even if whata person did or said was incorrect or misconceived, for example based on a misunderstanding of the situation or of what the law provides, they are protected against retaliation unless they were acting in bad faith. The reason for this is to ensure that people are not afraid to raise genuine concerns about discrimination because of fear of retaliation.

As well as it being unlawful to victimise a person who does a protected act, a child must not be victimised because of something done by their parent or a sibling in relation to the Act. This means that a child must not be made to suffer in any way because, for example, her mother has made a complaint of sex discrimination against the school, or her brother has claimed that a teacher is bullying him because he is gay, whether or not the mother or brother was acting in good faith.

If a pupil has himself or herself carried out a protected act — such as making a complaint of discrimination against a teacher - then the child's own good faith will be relevant. For example, if the parent's complaint is based on information from her son and the son was deliberately lying, it is not victimisation for the school to punish him in the same way as it might do any other dishonest pupil. Unless it can be clear that the mother was also acting in bad faith (for example that she knew her son was lying) it would still be unlawful to victimise her for pursuing the complaint.

The Dignity at Work policy contains more specific advice and examples in relation to Harassment and Victimisation in employment situations.

Under current legislation all schools have a 'General Duty' to:

- Eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by the Equality Act 2010.
- Advance equality of opportunity between persons who share a protected characteristic and personswho do not share it.
- Foster good relations between persons who share a protected characteristic by tackling prejudiceand promoting understanding.

#### **Race Equality**

The general duty to promote race equality means that we have due regard to:

- 1. Eliminate unlawful racial discrimination.
- 2. Promote equality of opportunity.
- 3. Promote good relations between people of different racial groups.

We follow recommended procedures for dealing with racist actions or any form of discrimination. The Trust schoolskeep appropriate records of all incidents.

## **Disability Equality**

The general duty to promote disability equality means that we have due regard to:

- 1. Promote equality of opportunity between disabled people and other people.
- 2. Eliminate unlawful discrimination.
- 3. Eliminate disability related harassment.
- 4. Promote positive attitudes towards disabled people.
- 5. Encourage participation by disabled people in public life.
- 6. Take steps to take account of disabled people's disabilities, even where that involves treating disabled people more favourably than other people.

#### Accessibility

There is specific disability legislation in relation to disabled students and accessibility which means we planstrategically over time to: Increase access to the curriculum.

- 1. Make improvements to the physical environment of the Trust to increase access.
- 2. Make written information accessible to students in a range of different ways.

We ensure that disabled students do not receive less favourable treatment and to do this the Trust has a duty tomake reasonable adjustments.

#### **Gender Equality**

The general duty to promote gender equality means that we have due regard to:

- 1. Eliminate unlawful discrimination and harassment.
- 2. Promote equality of opportunity between all genders.

The duty also includes the need to consider actions to address the causes of any gender pay gaps.

#### Transgender and students questioning their original gender

Transgender people are explicitly covered by the gender equality duty. The term 'transgender' refers to a range of people who do not feel comfortable with their birth gender. The Trust will provide a supportive and caring environment for any member of staff or child questioning their original gender. We recognise the highly complex nature of the issues that often accompany gender dysphoria in children. Xavier schools will support children who wish to legally change their name, pronoun or gender; however, we will use the names and pronouns assigned at birth until such a time that these are changed by deed poll. The only exception to this is in certain secondary school cases where the student and their family/careers have engaged with the school to request we use a different name or pronoun. We will ensure all stakeholders have the opportunity to carefully consider all factors associated with the request to agree a joint decision regarding next steps.

#### Age, sexual orientation, religion, belief, pregnancy and maternity

We ensure that we do not discriminate on these grounds and we take all reasonable actions to eliminate discrimination and harassment for these equality areas.

#### **Community Cohesion**

We always aim to promote community cohesion, developing good relations across different cultures, ethnic, religious and non-religious socio-economic groups.

#### Appendix 2 – Equality Objectives

The Xavier Catholic Education Trust's commitment to equality, a Diversity and Inclusion steering group was set up to meet termly and report to the Xavier Board. The aims of this group are to:

- 1. Ensure that there is a well-considered strategy in place to promote diversity and inclusion across allXavier schools and that, as part of this, under-represented groups are equitably treated.
- 2. Offer guidance and comment on, existing and proposed Xavier Trust's strategy to promote diversity and inclusion.

3. Provide a voice for under-represented groups across all Xavier schools. In its ways of working the group will model the values, behaviours and practises it promotes.

Whilst each MAT school will publish their own set of equality objectives, the Xavier Catholic Trust has also set out thefollowing objectives as central aims to help promote diversity and inclusion across the organisation as a whole.

#### In relation to Achievement:

- We are committed to improving the attainment of vulnerable groups of students, including students with Special Educational Needs, students with disabilities and those entitled to Free School Meals so that the gap between their attainment and that of other students is narrowed allowing for the best possible attainment by all students.
- We will aim to raise aspirations among children and young people, their parents and communities and raise awareness of career and higher education opportunities, to challenge stereotypes.

#### In relation to Teaching and Learning:

- We will ensure that our curriculum (including our programme of enrichment and extra-curricular activities) actively is broad and balanced and provides opportunities for all students and promotesunderstanding between different groups of people, cultures and societies. To ensure this is done with maximum impact, expertise will be used to review of our history curriculum.
- Our curriculum will include an element of PSHE education that tackles stereotypes and challengesstudent's perceptions.
- We will ensure that Teach SouthEast provide appropriate training for trainee teachers in diversity and inclusion.

## In relation to Behaviour and Safety:

- We will maintain a rigorous anti-bullying stance so that all students and staff, including those withprotected characteristics, are protected from harassment and discrimination of all kinds.
- We will ensure the promotion of our Catholic values and British values through our curriculum. Thiswill support and develop our students into responsible citizens of the future.
- Our behaviour policies will outline how we will deal with students who use discriminatory homophobicor otherwise offensive language.
- We will promote the use of the <a href="DIFT@Xaviercet.org.uk">DIFT Discrimination Incident</a> Reporting Form)email address to report and manage discrimination effectively on a Trust level.

#### In relation to Leadership and Management:

- We will demonstrate our commitment to equality and diversity through consistent application of ourpolicies and procedures.
- We will ensure that our systems for recruiting, retaining and managing staff (and potential applicants) support all those in groups protected by the Equalities Act.
- We will undertake equality assessments of all new and existing policies and procedures.

# How we will consult and engage our stakeholders with regard to our strategy to promote diversity and inclusion:
