Close family member includes any spouse, child, stepchild, parent, grandparent, grandchild or sibling of the senior employee, Director/Trustee or Member, or any person living with them as his or her partner.

Senior employees, Directors/Trustees and Members are specifically required to declare their interests in transactions or arrangements which are proposed but not yet entered into by the Trust, and to declare any interest in any existing transaction entered into by the Trust which could give rise to a conflict of interests.

The information in this register must be kept up to date by notifying the Company Secretary or Chair in writing.

Please note that all of the information included within the Register of Interests will be available to the Members, all Directors/Trustees and other officers of the Trust. In addition, the Register of Interests will be published on the Trust's website as required by the Charity SORP (with information relating to the interests relating to close family members redacted).
